
#### National Co-Production Week: 3–8 July 2017

Family Voice Norfolk and the local authority have been working hard to mark National Co-Production Week. Both organisations believe that the best way to ensure that services take into account the views and experiences of service users – you! – is to work in partnership when planning, developing and reviewing provision. National Co-Production Week is an opportunity to show what that means in Norfolk.

• A special edition of *Improving Times* weekly newsletter (Children's Services), which will also appear as a special edition of the SEND e-Newsletter, includes many examples of co-production in practice, including several that Family Voice has been involved in. Family Voice members have written articles worked alongside the Local Offer to edit and organise the newsletter. The hope is that further areas of the local authority will appreciate the benefits of co-production for all concerned.

• Some footage has already been shot for a short film, which will appear on the Local Offer, YouTube and the Family Voice website, showing co-production in practice and what it means in Norfolk. Children and young people, Family Voice members and representatives of the local authority will all appear, and the filmmaker is Jacob Furniss, himself a young man with SEND.

As well as being an excellent example of co-production in itself, the film will show more clearly than any explanation what it is that Family Voice Representatives actually do!

## Update from the Reps Team



Hi, I'm Cheryl and mum to a teen with a diagnosis of ASD and complex needs. Having heard about the work of Family Voice Norfolk in listening to and

representing the views of families across the county, I joined the Reps Team in March last year. I wanted to get involved in helping to shape and improve services for all our children and young people with SEND and their families. I was – and continue to be – passionate about the opportunity to try to make a difference.

After the AGM in May, I was pleased to take on the role of leading our highly committed Reps Team. Representing the voices of Norfolk families, we continue to be involved in a wide range of strategy groups and project boards with our partners from Norfolk County Council's Education Inclusion Service, Children's and Adult's Social Services, Information and Advice Services, Health and Voluntary Sector providers. Many of the groups we are involved with have what's known as 'multi-agency' representation, seeking to bring professionals from all the teams involved in delivering a service around one table.

We are always looking for more parent carers to join our team and are particularly hoping to involve more families living in the east of the county and those with experience of palliative care needs.

The first step would be to come and have coffee and a chat to find out what's involved. You'll never be pressured to do more than you can fit in with family and other commitments.

Here's an update of key areas where the Reps Team has been busy this month.

In June, Family Voice Norfolk Reps attended a meeting with Rachel Gates, local authority Disability and Health Commissioner. We discussed our recent membership consultation, which asked families to tell us about their views regarding changes to the way Short Breaks are commissioned. You can read the results of the consultation on the Family Voice Norfolk website at http://familyvoice.org.uk/index.php/news. Following the meeting, Family Voice Norfolk continues to have concerns about the suitability of the RAS (Resource Allocation System) questionnaire to reflect the true need of every family to have a Short Break. We are also worried about the impact and extent of the confusion around the allocation of budgets and provision available.

In July, we hope to launch a second, wider consultation in partnership with NASSH (Norfolk Association of Special School Headteachers), which will help us to audit the Short Breaks experiences of a larger number of Norfolk families. We want to reach as many affected families as we can, so will use several different ways to reach both our members and other families. When we contact you, please feel free to encourage other families you may know to complete our survey as well as giving us your own response.

We also attended the NSFT (Norfolk Suffolk Foundation Trust) Transition Planning meeting, part of a national initiative to drive clinical quality improvements and transformational change to the experiences and outcomes for young people as they transition out of the Children and Adolescents Mental Health Service. Family Voice Norfolk was extended a warm welcome at this meeting. We look forward to working as a key part of this initiative.

Concerning news from families of a consultation being launched regarding the proposed closure of the Autism SRB (Specialist Resource Base) at the Open Academy, Norwich, led to members of the Family Voice Steering Group raising their concerns at a meeting with Education Inclusion Commissioner Nikki Rider. We will also highlight this via our Eastern Region

Parent Carer Forum Rep to the NNPCF (National Network of Parent Carer Forums), whose Reps sit on national planning and project meetings. Our aim is to ensure that the actions of Academies and their effects on children and young people with SEND and their families will be discussed and heard at government level.

#### Chair of Children's Services Committee



Following the local government elections in May, the posts and responsibilities of councillors have changed. The new Chair of the Children's Services Committee is Councillor

Penny Carpenter, who represents the Caister division, having previously served on the Great Yarmouth Borough Council as deputy council leader. A Conservative councillor, before retiring she worked for Norfolk Constabulary as a Civilian Crime Reduction Officer. As a councillor, she has been very active in community initiatives and led the response to the Regent Road fire last year that affected many Yarmouth businesses.



#### 1) Your feedback needed...

In a previous newsletter we reported on a piece of work that Family Voice was involved in with the local authority and a number of other partners to set down what education settings can be expected to supply in terms of SEN Support.

Members have told us that the provision they can currently expect from schools and colleges varies very much and that they are given conflicting messages about how SEN Support relates to EHC Plan assessments. We have made the local authority aware of your comments and this is an area in which they also feel that further clarity is needed. This will help both education settings to know what is expected and parent carers to know what their children and young people have a right to receive.
