

# **Family Voice Norfolk Privacy Policy**

Family Voice Norfolk is the parent carer forum for Norfolk. This privacy policy explains how we use any personal information we collect about you when you use this website or are in touch with us in other ways.

We collect and use different kinds of information:

- 1. **Identifiable data** containing personal data that can identify individuals, such as name, date of birth, gender, address and postcodes.
- 2. **Pseudonymised data** this contains information about individuals but with the identifiable details replaced with a unique code.
- 3. **Anonymised data** this is information about individuals which has had all identifying details removed.
- 4. **Aggregated data** this is when all anonymised information has been grouped together so that it doesn't identify individuals.

### What information do we collect about you?

We collect information about you and your family when you register with us by completing a membership form on our leaflet or website. We also collect information when you voluntarily complete online surveys, provide feedback and participate in our consultations. Information about use of our website is collected using cookies. You can find out how we use these here.

### How will we use this information about you?

You may supply us with information in writing, online via our website, Facebook, Twitter or email, or verbally to our Membership Secretary, representatives or ambassadors. We use any issues and concerns you raise with us to help compile reports that track what is working well, what is not working well and what is changing in the services that children and young people with special educational needs and/or disabilities receive.

Family Voice Norfolk will never share your personal information with any third-party organisation unless required to do so by law. Reports that we compile are made widely available, in order to improve services for our membership and their families, but information will always be anonymised and any details removed that could identify you.

### Access to your information and correction

You have the right to request a copy of the information that we hold about you. If you would like a copy of some or all of your personal information, please email our Membership

#### **Cookies**

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. This information is used to track visitor use of the website and to compile statistical reports on website activity.
